

Metro SWAT had 20 missions in 2016 which is down from 22 the year prior. CSO's were busier than usual with transports, Property Room, Crime Analysis, Electric Home Monitoring programs, National Night Out and the Citizens Academy to name a few of the programs they were involved in. Our Traffic Unit was focused on impaired drivers and worked the school zones heavily in order to have our kids get to and from school in a safer environment. The Traffic Unit also participated in several fun runs throughout the year.



Investigations Unit Detective Sergeant T. Longtine, Det. Byerley, Det. Kocher, Det. TFO Scott, Det. TFO Torgerson

The Investigations unit is staffed by a Detective Sergeant, and two general detectives. In addition, the Investigations Unit has a full-time narcotics detective assigned to the DEA task force and a full-time detective assigned to the P.A.T.R.O.L. Auto Theft Task Force. The Investigation Unit were assigned 360 cases in 2016 that is an increase of 115 cases over last year, most of which were felony crimes, of those 273 cases were cleared. The detectives prepared and executed more than 30 search and seizure warrants related to those investigations.

The Investigations Unit investigated many serious felony crimes that consisted of sexual crimes, crimes against children, fraud and felony assault/domestic violence. Some of the highlighted cases from late 2016 are as follows:

Detectives investigated a bank robbery at Chase Bank. The subject(s) were ultimately arrested and charged with more than 10 bank robberies throughout the region.

Detectives resolved a shooting incident from 2015, with the defendant receiving 114 month sentence for his crimes.

Our detectives and patrol staff, arrested two subjects for theft of mail. Both were subsequently charged with 11 counts of mail theft.

All of our detectives participated in the Bonney Lake Citizens Academy and 2 conducted various training of department personnel as part of the training unit.

Our detectives investigated multiple other cases which lead to felony convictions resulting in prison sentences and/or confinement in the Pierce County Jail.

Detectives assisted with several investigations as part of the Pierce County Metro Crime Response Unit including; multiple homicide investigations as well as several officer involved shootings.

Detectives participated in several specialized training classes including: Washington State Homicide Investigators Association annual conference, buried body investigations, statement analysis and Child Abduction training.



Our detective assigned to the P.A.T.R.O.L task force conducted numerous investigations of stolen vehicles. The task force as a whole initiated 139 cases, resulting in 57 arrests, and 253 vehicle recoveries with an estimated valued of more than \$2.8 million dollars.

Tahoma Narcotics Task Force (TNET) Detective Sergeant T. Longtine

Our detective assigned to the Drug Enforcement Administration Task Force in Tacoma, participated in several large scale investigations, which resulted in the seizure of six pounds of Cocaine, 118 pounds of Methamphetamine, 17 pounds of Heroin, 1656 pounds of marijuana, and 940 dosage units of prescription drugs being seized. In addition the task force arrested 115 people and seized \$1,842,306 in assets.

Special Weapons And Tactics (SWAT) Sergeant Hoag Officer Vance and Officer Alfano

Metro SWAT is a part-time, multi-agency tactical team which consists of officers from the Bonney Lake, DuPont, Fife, Lakewood, Milton, Orting, Puyallup, Steilacoom, and Sumner Police Departments. The SWAT team is responsible for responding to high-risk incidents in the participating cities. In 2016, the Bonney Lake Police Department had two officers who were assigned to Metro SWAT as an additional collateral duty. Officer Vance is trained as a SWAT Operator as well as a Tactical Breacher on the team. Officer Alfano is trained as a SWAT Operator and also became an Assistant Team Leader for SWAT during 2016. The Bonney Lake Metro SWAT members successfully completed 20 missions in 2016. This was a decrease from 22 missions in 2015. In 2016, the Metro SWAT team was utilized for apprehending barricaded felony suspects, serving felony arrest warrants, search warrants for stolen firearms, and high risk search warrants. In addition to responding to high-risk situations, members of Metro SWAT provide training to local police agencies in the areas of firearms, patrol tactics, active-shooter response, high risk entries, and defensive tactics. Officer Alfano was awarded the Medal of Valor and the Medal of Merit for his heroic action during two SWAT calls in 2016.

Tacoma/Pierce county DUI Task Force Sergeant Hoag

The Bonney Lake Police Department continued its participation in the Tacoma/Pierce County DUI Task Force. The task force is designed for law enforcement agencies in Pierce County to work as a cooperative group to concentrate DUI and traffic enforcement efforts throughout various locations in Pierce County. Each month, officers from these different agencies work DUI or speed emphasis in the local area of the host agency. The DUI Task Force was developed in 1983 when citizens were appointed by Tacoma and Pierce County elected officials to design and implement an education, public information, and enforcement program. Since that time, the program's scope and community involvement has continued to expand and has evolved into today's DUI Task Force.

Bonney Lake Traffic & Patrol Officers worked DUI emphasis patrols in Tacoma, University Place, Puyallup, Fife, Bonney Lake/Sumner/Buckley and areas of unincorporated Pierce County. Bonney Lake hosted the DUI Emphasis Patrol on January 23rd, 2016. During this emphasis patrol 156 traffic stops were made, 61 NOI's/criminal traffic citations were issued and most importantly 13 DUI arrests were made. The Bonney Lake Police Department continued it's participation in the Washington State Patrol's Target Zero Team. Target Zero is the state's strategic highway safety plan, and calls for reducing highway deaths to zero by the year 2030. The entire plan can be found at <u>www.targetzero.com</u>. Enforcement is one of four equal strategies of Target Zero, along with engineering, education and emergency medical service. Grants from the Washington State Traffic Safety Commission reimburse law enforcement agencies' salaries for their involvement in these programs. Sergeant Robert Hoag continued to represent Bonney Lake as a member of the Target Zero Team. Sergeant Hoag made DUI arrests in Tacoma, Puyallup, Bonney Lake, Sumner and Unincorporated Pierce County in 2016.

Traffic Unit Sergeant R. Hoag Ofc. V. Sainati and Ofc. E.Alfano

We had a successful traffic enforcement year as we experienced **zero** traffic related deaths and only one serious injury collision in 2016.

The traffic unit issued a total of 2530 traffic infractions/citations in 2016. We focused heavily on school zone and DUI enforcement this past year. Officers issued 183 infractions/citations in school zones, wrote 358 parking tickets and processed 86 impaired drivers. As an entire department, Bonney Lake Officers issued 5014 traffic infractions/citations. In addition to traffic enforcement, the traffic unit was involved in education events during the Bonney Lake Citizens Academy and assisted with traffic control for numerous community events during the year. Traffic units assisted with the 5K Sumner School District Fun Run, Bonney Lake Days, Labor of Love Triathlon, Halloween event in Sky Island and the 5K Tour-de-Lights Fun Run. The traffic unit investigated 250 reportable collisions in 2016. This was up slightly from 249 collisions in 2015. This year we announced special traffic emphasis patrols designed to address specific traffic safety concerns. Several of these emphasis patrols focused on the following five traffic safety priorities:

Officer Sainati continued as our traffic motorcycle officer in 2016. Officer Sainati continued to ride his BMW motorcycle in nearly all weather conditions. In addition to traffic enforcement Officer Sainati employs the motorcycle in support of numerous community events. Officer Sainati participated in department open houses, Bonney Lake Days, National Night Out, Labor of Love Triathlon, Sumner School District 5K Fun-Run and numerous department functions.

Officer Alfano and Sergeant Hoag both became Technical Collision Investigators by attending training in 2016.

Officer Alfano became a certified Drug Recognition Expert in 2016.

Metro Collision Response Team (MCRT)

Sergeant R. Hoag Ofc. V. Sainati, Ofc. E.Alfano and Ofc. T. Green

The Metro Collision Response Team is a part-time, multi-agency collision investigation team that consists of traffic investigators from Lakewood, Puyallup, Bonney Lake, Sumner, Dupont, Milton, Fife and Buckley. MCRT is responsible for responding to and conducting investigations at serious injury and fatality collision scenes in the participating cities. MCRT responded to fifteen serious injury or fatality collisions in 2016. MCRT investigated collisions in the following jurisdictions during 2016:

Puyallup PD purchased a FARO 3D Scanner for application in crime scene and major collision investigation scanning. Sergeant Hoag and Officer Alfano attended a week long course to become trained on the use of the FARO scanner and software. MCRT participated in quarterly training in January, March, May, July and October. MCRT training consisted of Total Station review, Time Distance Scenarios, 3D FARO Scanner Training, Accelerometer applications, CDR Downloads, and Collision Case Studies. All of the MCRT collision investigators became familiar with the FARO scanner during these training classes and used the equipment to map a collision scene.

Party Intervention Patrol Sergeant R. Hoag

Pierce County's Party Intervention Patrol (PIP) is a grant funded task force funded through Tacoma Pierce County DUI & Traffic Safety. Bonney Lake is just one of several East Pierce County law enforcement agencies that participate in the task force designed for law enforcement agencies in Pierce County to cooperatively reduce underage drinking through enforcement, intervention and education. Bonney Lake officers participated in six PIP emphasis patrols in 2016.

Property Room Sgt. Sasaki CSO Yanez

The property room began the year with the annual appropriated property audit. There are 74 items appropriated to various officers or work spaces within the department. One (1) item was destroyed and/or depleted through department training with all other items accounted for.

We received and processed into our evidence room approximately 870 items for 2015. We processed 75 release requests for return of property to the applicable owners/victims.

The property room has continued to strive to maintain effective property room management by the disposing of evidence that is no longer required to be retained in the evidence room. Through case research, we were able to dispose and/ or destroy 632 items for 2015. We had a total of 90 items of illegal drugs, 517 items of property and no firearms that were destroyed.

There was a total of 12 items that went to Propertyroom.com for auction that generated an approximated total of \$78.27 in additional revenue for the department. We are making continued progress of transitioning over to the new bar code system.


Community Service Officers of the Bonney Lake Police Department continued to provide excellent support working with our Patrol Officers, Sergeants and Command Staff in 2016. Community Service Officers (CSO's) also worked to promote Crime Prevention and Community Oriented Policing in both the residential and business community.

Although CSO's have a wide range of duties and responsibilities there are several which can be considered primary that included: prisoner transports, Bonney Lake Municipal Court security, property room management, electronic monitoring, and crime analysis. CSO Miller is also assigned to P.A.T.R.O.L. the Regional Auto Theft Task Force.

Crime Prevention and Community Events Cont

Community Service Officers of the Bonney Lake Police Department continued to provide excellent support working with our Patrol Officers, Sergeants and Command Staff in 2016. Community Service Officers (CSO's) also worked to promote Crime Prevention and Community Oriented Policing in both the residential and business community.

Although CSO's have a wide range of duties and responsibilities there are several which can be considered primary that included: prisoner transports, Bonney Lake Municipal Court



security, property room management, electronic monitoring, and crime analysis. CSO Miller is also assigned to P.A.T.R.O.L. the Regional Auto Theft Task Force.

CSO's continue to transport inmates to and from jail. Felony prisoners are transported primarily to Pierce County Jail, while gross misdemeanor and misdemeanor prisoners were transported to jails such as: Enumclaw, Puyallup, Fife, Nisqually and SCORE, depending upon available jail space. CSO's transported a grand total of 538 prisoners this year, which is 51 more than in 2015.

CSO's also supervise Day Court prisoners, which are offenders who have been convicted and are serving their time in court. Day Court allows prisoners a chance to serve their time in the courtroom instead of being incarcerated. CSO's supervised a total of 88 Day Court prisoners in 2016, saving the city approximately \$5,720 in jail costs



CSO Alvord oversees and supervises the Electronic Monitoring Program for the BLPD. The offenders participating in this program have been sentenced to electronic monitoring by BLMC instead of being incarcerated. Electronic Monitoring reduces jail cost and allows offenders to work while serving their sentences. BLPD supervises defendants that have been sentenced to Electronic Home Monitoring and Transdermal Alcohol Detection. 14 offenders were sentenced to Electronic Monitoring in 2016 with a total of 634 days of monitoring. 393 days were served by offenders participating in the Home Monitoring program and 241 days were served by offenders participating in the Transdermal Alcohol Detection program. This monitoring saved the City of Bonney Lake approximately \$41,210 in jail costs for 2016.

Throughout 2016, CSO's and Police Volunteers participated in a variety of community and school events to include: Bonney Lake Days, National Night Out, Citizen's Academy, Open House, Scout Night and Shop with a Cop, to name a few. Our Community Service Officers also attended three block watch meetings this year

The Marine Unit in conjunction with the US Coast Guard Auxiliary, started the 2016 boating season by instructing two boater education courses, one in March and the other in April; educating approximately 27 students. Prior to scheduling shifts on Lake Tapps, officers completed a new mandatory annual eight hour training course. Bonney Lake Police sponsored the training, and jointly completed the training with the Lakewood Police Marine Unit. The ten hour training day consisted of, securing the boat on its trailer, trailering the boat and placing it back in the water, along with an on the water obstacle course and a higher speed maneuver. We also worked with the new Sumner YMCA and have been given the green light to use their pool for our annual water training. Our pool training consisted of a water rescue, lap swimming, use of an inflatable PFD and the use of a standard type II life vest.

Officers inspected every City owned buoy; replacing two buoys and provided maintenance to several. The Marine Unit, in conjunction with the US Coast Guard Auxiliary, worked together during two boater education courses, and at East Pierce Fire's Open House.

The Marine Unit reduced the number of assemblies per school to assist with efficiency. This year Officers were in six school districts; Sumner, White River, Dieringer. Fife, Auburn and Carbonado, educating approximately 8,093 students.

The Marine Unit investigated a boating collision with an injury, filing several charges in that incident. Officers assisted Pierce County with a boating collision, where the suspect had fled the scene. Officers responded to a medical condition which occurred on the water, aiding the victim until fire arrived. This season, officers worked nearly 190 hours on the water and at the boat ramp; enforcing State and Local laws, while assisting citizens and patrol officers at Allan Yorke Park.

The Marine Unit participated in city events; Bonney Lake Days, and Open House. Also a new water safety video made by Officer Wolschleger and the students from videography at the Bonney Lake High School. The video was played at Allan Yorke Park prior to each outdoor movie. The safety video was just a reminder to parents, family and children of how to be safe while around bodies of water. Marine

Allan Yorke Park was staffed by BLPD Officers on weekends and holiday when weather permits. The Allan Yorke Park detail consists of Officers signing up for extra shifts when they are not on regular patrol. In addition to the weekend and holiday patrols, Officers worked several City sponsored events at the park, including several Tunes at Tapps, National Night Out and Bonney Lake Days. This year we had some increased gang activity and some large crowds that were dealt with at the beginning of summer both by patrol and the officer picking up the AYP detail. There were days graveyard staff was called in early to deal with some of the issues at the park.

Officers conducted countless social contacts and other interactions with citizens during the various park events. Each Officer was required to fill out a statistic sheet for each shift worked. The statistics were compiled from these sheets and the results are listed below.

The National Incident Based Reporting System (NIBRS) is an incident-based reporting system for crimes known to the police. For each crime incident coming to the attention of law enforcement, a variety of data are collected about the incident. The data includes the nature and types of specific offenses in the incident, characteristics of the victim (s) and offender (s), types and value of property stolen and recovered, and characteristics of persons arrested in connection with a crime incident. The total number of NIBRS offenses reported to Bonney Lake Police Department for 2016 was 1, 111. That is an increase of 12% compared to 992 NIBRS crimes reported in 2015.

While overall NIBRS offenses were slightly up in 2016, a decrease was noted in Forcible Sex Offenses (-7.7%), Non-Force Sex Offences (-66.7%), Counterfeiting/Forgery (-29%), Fraud (-14.8%), Stolen Property Offenses (-12.5%), Drug Offenses (-9.4%) and Weapon Law Violations (-22.2%). Several NIBRS offenses were up in 2016 to include: Aggravated Assault (16.6%), Simple Assault (6%), Burglary (22.4%), Theft/Larceny (17%), Motor Vehicle Theft (100%), Destruction of Property (19.6%) and Violation of No Contact Order (39.3%).

Child Passenger Safety Project Manager Cesi Velez

Washington's Child Passenger Safety Program has been based out of the Bonney Lake Police Department since 2012. Statewide coordination of the State's program has been conducted by Cesi Velez, Project Manager. The results of 2016 align with the averaged activities and results of prior years. In an effort to educate Washington residents and equip families with the appropriate child restraints; the following occurred:

5,007	Car seats inspected
1,429	Car/booster seats provided to families in need
103,877	People were reached with education
80,456	Pieces of educational material distributed

In addition to the above, efforts were made to increase and strengthen the network of nationally certified car seat technicians and inspection resources:

11 Child Passenger Safety Technician (CPST) courses were offered throughout Washington. 85 participants attended the courses to obtain certification.

The Project Manager also facilitates a mini-grant program to support all of the above actions. Up to \$105,000 is distributed on a reimbursement basis to the local child passenger safety teams. The funds are routinely used to support the following:
